Hours worked	28
Gross Pay	£616.00
Deductions from your wage required by law:	Income tax (£74.85) Employee National Insurance (£45.00) Student Loan Plan 1 (£17.34)
Example net take home pay:	£478.81
Accrued Holiday (Hours)	3.38

If you have a Student Loan Plan 2, the following net pay would be:

Student Loan Plan 2	£8.20
Example net take home pay:	£487.95

If you have a Postgraduate Loan, the following net pay would be:

Student Loan Postgraduate Loan	£12.73
